

s I have been out in our community this summer, I have heard from Calgarians about the issues that are top of mind for them.

The issues that came up most often in conversations were:

- Inflation
- Housing affordability
- Jobs/economy
- Immigration
- Federal spending
- High taxes
- Infrastructure investment
- National security
- Homelessness

As you can see, Calgarians are concerned not only about the affordability of their homes, but what happens if they lose their homes.

It is essential, then, that we understand what housing in Calgary looks like now and how that compares to the past.

Since 1986, the federal Canadian Mortgage and Housing Corporation (CHMC) has advised that Canadians spend no more than 30% of their income on housing. This number is also supposed to include utilities and municipal services.

Every Canadian knows that this is no longer realistic or achievable. According to the "30% rule", in order to afford a two bedroom apartment, the average Calgarian must make nearly \$70,000 a year. In order to afford the average detached house (with a minimum downpayment), the average Calgarian must make nearly \$200,000 a year.

Mortgages, rents, and rates of homelessness are all on the rise in Canada, especially in Calgary. In this mailer, you will find more information about housing in Calgary and the chance to have your say about the Liberal housing plan.

CALGARY HOUSING FACTS



Since 2011, the number of renters in the city has grown 37.3%, while the number of homeowners has grown by just 15.9%.



The average rent for a two bedroom in Calgary increased by 14.3% in 2023. This was the highest year-on-year growth in Canada.



In 2023, the median price for a detached home in Calgary was \$710,000, up 31% from \$540,000 in 2015.



In the riding of Calgary Confederation, 54.6% of residents own their homes and 45.4% rent.



Calgary's population grew by 5.6% in 2023. It is expected to grow by another 4.9% in 2024.



In 2022, the vacancy rate for two bedroom apartments in Calgary was 2.7%. In 2023, it was half that at 1.4%.



In 2023, Calgary was the fastestgrowing major municipality in Canada. By 2029, the population is projected to be over 1.6 million people.

PROBLEM 1:

Prolonged approvals stifling development.

Require the CMHC to speed up approval of housing program applications to an average of 60 days.

Require cities to increase the number of homes built by 15% each year, or lose a percentage of their federal funding.

PROBLEM 2:

A lack of affordable housing.

HOUSING SOLUTIONS

Remove GST on new builds with rental prices below market value.

List 15% of the federal government's 37,000 buildings (and all appropriate federal lands) to be turned into affordable housing.

Reward cities that exceed a 15% increase in housing completions.

Provide "super-bonuses" to any municipality that greatly exceeds housing targets.

Cut bonuses and salaries, and, if needed, fire the gatekeepers at the Canadian Mortgage and Housing Corporation (CMHC).

Withhold transit and infrastructure funding from cities until sufficient high-density housing around transit stations is built and occupied.

PROBLEM 3:

Bureaucrats are preventing homes from being built.
